 Savage Field Lighting and Funding Update (Guests: Chris McGown, Building Committee and Russ Karlstad Facilities Department - 20-30 mins)

\*Motion made to move this discussion up. Mr. McGown reviewed Warrant Article in June 2016 meeting for Phase I. Entire project was bid on and came in over budget. This resulted in reconsidering the overall project and the remaining \$177,000. The options include redesigning the parking lot, going to town meeting, or calling for a special town meeting in order to reallocate the funds from Phase 1 of the Savage Field Renovation.
